(a) Amount Beneficially Owned:

As of the close of business on February 28, 2019, Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), beneficially owned 1,310,600 shares of the Issuer's Class A Common Stock or 5.2% of the Issuer's Class A Common Stock outstanding as it held 1,310,600 of the Issuer's units. Each unit consists of one share of the Issuer's Class A Common Stock and one-third of one warrant. Each whole warrant entitles the holder to purchase one share of the Issuer's Class A Common Stock. The Issuer's warrants will become exercisable on the later of 30 days after the completion of the Issuer's initial business combination and 12 months from the closing of the Issuer's initial public offering.

Thereafter, as of the close of business on March 5, 2019, Integrated Core Strategies beneficially owned 1,200,000 shares of the Issuer's Class A Common Stock or 4.8% of the Issuer's Class A Common Stock outstanding as it held 1,200,000 of the Issuer's units.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies.

Millennium Group Management LLC, a Delaware limited liability company ("Millennium Group Management"), is the managing member of Millennium Management and may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies.

Israel A. Englander, a United States citizen ("Mr. Englander"), controls the managing member of Millennium Group Management and may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies.

The foregoing should not be construed in and of itself as an admission by Millennium Management, Millennium Group Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies.

(b) Percent of Class:

As of the close of business on March 5, 2019, Integrated Core Strategies, Millennium Management, Millennium Group Management and Mr. Englander beneficially owned or may be deemed to have beneficially owned, as the case may be, 1,200,000 shares of the Issuer's Class A Common Stock or 4.8% of the Issuer's Class A Common Stock outstanding (see Item 4(a) above), which percentage was calculated based on 25,000,000 shares of the Issuer's Class A Common Stock outstanding as of March 4, 2019, as per the Issuer's Form 8-K dated March 4, 2019.
